## Fremont Community Recreation Complex Pass Agreement

- All passes are non-transferable and considered void if used by anyone other than the original specified pass holder(s).
- All pass holders are expected to observe the rules and regulations relating to the safety and operation of the facility. Staff reserves the right to establish all facility rules, regulations, reservation policy, fees and charges, programs and classes, operating hours and overall management of the facility. Any changes in rules, regulations or policies will be made at the direction of the staff and will be posted to inform all pass holders.
- Any pass holder who fails to comply with these policies and procedures and any conduct considered improper or any infringements caused to other pass holders will be grounds for action. The Fremont Community Recreation Complex (FCRC) reserve the right to revoke any passes and/or impose evictions from the facility and grounds.
- Identification must be presented to the front desk personnel upon each visit or if otherwise requested. If a patron does not produce identification, an alternate form of photo identification will be required for admission into the facility.
- Pass holders shall remain in good standing as long as fees are current. Failure to keep an account current shall result in suspension or termination of the pass.
- Occasionally the FCRC and/or specific facilities may be closed due to repairs, maintenance and/or special events. Such closings will not result in a deduction from pass holders costs. The times and dates of any closing will be posted in advance to inform pass holders.
- Family members may be added to an annual pass at any time during the year full price or pro-rated, priced according to the number of people on the pass. When adding additional family members, the pass will expire on the original purchase date. Payments will remain the responsibility of the primary pass holder \_\_\_\_\_ (initial)
- Pass holders use the FCRC at their own risk. The facility is not responsible for the lost or stolen articles in the facility.
- Dependents must adhere to the following guidelines regarding the use of facility:  
Children 13 years and under must be directly supervised by a parent or chaperone who is 18 years of age or older in the facility at all times. Pass holders 15 years and older may use the running track. Minors 15 years and older may use the upstairs weights without a parent. You must be 18 years or older to use the free weight room downstairs or accompanied by an adult under strict supervision \_\_\_\_\_ (initial)
